

Event Attendance Terms & Conditions

By purchasing a ticket / making payment or attending this event, you agree to the following terms:

1. Tickets & Entry

Tickets are non-refundable unless the event is cancelled by the organizer.

Lost, stolen, or damaged tickets will not be reissued.

Admission may be refused if a ticket is invalid, altered, or purchased through an unauthorized source.

Attendees may be required to present valid identification upon entry.

Entry may be subject to security checks, including bag searches.

2. Event Conditions

The event may take place indoors, outdoors, or a combination of both. Attendees are responsible for preparing appropriately for weather conditions. The organizer is not responsible for weather conditions.

The organizer reserves the right to make changes to the program, schedule, or venue as necessary.

Third-Party Suppliers & Entertainment – The organizer is not responsible or liable if an advertised third-party supplier, performer, or entertainer is unable to participate. While all activities and appearances are advertised in good faith, unforeseen circumstances may arise. In such cases, the organizer will make reasonable efforts to provide a suitable replacement or alternative activity.

3. Code of Conduct

Attendees must treat staff, performers, vendors, and fellow guests with respect.

Abusive, threatening, or disruptive behaviour may result in removal without refund.

Harassment, discrimination, or offensive conduct of any kind will not be tolerated.

4. Safety & Liability

Attendance and participation are at your own risk. The organizer accepts no liability for injury, loss, or damage to personal property unless caused by proven negligence.

Children under 14 must be accompanied by a responsible adult at all times.

Attendees must comply with all safety instructions provided by event staff.

5. Photography & Media

The event may be filmed or photographed. By attending, you consent to your likeness being captured and used for promotional purposes.

Personal photography is permitted unless otherwise stated by the organizer.

6. Refunds & Cancellations

Refunds will only be issued if the event is cancelled by the organizer.

In the event of rescheduling, tickets will automatically transfer to the new date.

Early Departure & Refunds

Once admission has been paid, no refunds will be issued for attendees who choose to leave the event early, regardless of the length of time spent at the venue.

Refunds to Original Payment Method

All approved refunds will be processed to the original payment method used at the time of purchase. Refunds can not be redirected to a different account, card, or payment method. Please allow 7 business days for processing, depending on your payment provider.

7. Prohibited Items

Illegal substances, weapons, and dangerous items are strictly prohibited.

Alcohol may only be purchased and consumed in designated areas.
